



IV. Breach of Terms and Conditions

1. It is a breach of these Terms and Conditions for any cardholder in the reasonable opinion of BCCI to: abuse any privileges, facilities, services or arrangements accorded to the cardholder as a result of Membership in BCCI; or act in any fraudulent manner or in any way which is likely to be detrimental to the interest of BCCI or BCCI Membership Privilege Card Program or any Partner, supply or attempt to supply misleading information, or make any misrepresentation to BCCI or any Partner; or act in any way which in BCCI's reasonable opinion breaches or is likely to be detrimental to the interest of BCCI or BCCI Membership Privilege Card Program or any Partner, supply or attempt to supply misleading information, or make any misrepresentation to BCCI or any Partner; or act in any way which in BCCI's reasonable opinion breaches or is likely to breach these Terms and Conditions. BCCI's decision as to what constitutes a breach shall be final and conclusive.
2. Any breach of Terms and Conditions whether intentional or otherwise may result in termination of the Card and cancellation of Privileges at the sole discretion of BCCI. Eligibility for future or further participation in the BCCI Membership Privilege Card Program shall likewise be affected.

4. BCCI is not a supplier of the products and services shown as Privileges and will not accept liability in relation thereto.
5. The cardholder is solely responsible for the use of any Privilege; whether the Privilege is used by the cardholder or by a third Party.
6. The cardholder is personally liable for any and all costs, charges, claims or liabilities including duties, taxes and fees from third parties, government and non-government entities of whatever nature arising from the use of any Privilege, as provided by BCCI Membership Privilege Card Program and the use of any Privileges.
7. The cardholder hereby understands and agrees that the successful operation of BCCI Membership Privilege Card Program is based on the cooperative interaction among BCCI, the Members, and the Partners. The Member also hereby understands and agrees that the proper implementation of the Terms and Conditions between BCCI and the Member is closely related and/or intertwined with the proper implementation of the Partner Agreement between BCCI and each Partner.

Duration and Renewal

Your membership privilege card is valid for one year and is automatically renewed upon membership renewal.

TERMS AND CONDITIONS:

The Terms and Conditions stated herein, as defined by Bulacan Chamber of Commerce and Industry, Inc. (BCCI), form the basis and guidelines of the issuance and usage of the

BCCI Membership Privilege Card and defines the rights and obligations of the cardholder. Cardholders are subject to these guidelines and are deemed to have accepted the Terms, Conditions, Guidelines and Rules thereof upon signing the form.

I. BCCI MEMBERSHIP PRIVILEGE CARD

1. The card is valid for one (1) year which covers period from January to December. Membership must be renewed before expiration in order for members to continue enjoying the benefits of the program.
2. Each member is obligated to keep his information file up-to-date by reporting any change in name, address and other data. Members may do so by filling up the BCCI Membership Profile Update Form. Verbal notification is not valid and will not be entertained.
3. Member agrees to receive communication, including but not limited to electronic and postal materials, from BCCI. Such materials may be in form of program updates, exclusive promotions and tie-up offers that BCCI deems beneficial to the member.
4. BCCI reserves the right, at its sole discretion and without prior notice, to cancel the Membership Privilege Card of any individual and all Privileges that go with said membership.
5. All rights and privileges will terminate automatically on the event of non-renewal of membership.

II. Use of the BCCI Membership Privilege Card

The Membership Privilege Card is and shall remain the property of BCCI and must be returned on demand.

1. The Card is not transferable in any circumstance, and is valid for use only by the BCCI Member Companies' Official Representative registered with BCCI, who must present it when conducting any transaction.
2. The Card is not for identification purposes. The Card must be presented to the participating merchants together with a valid ID to avail discounts, special offers, and freebies within participating merchants.

3. The Card may not be used at the time of purchase and/or activity that is identified by BCCI and/or program Partner as not eligible for discounts or other promos.
4. In case of lost or damaged Card, it may be replaced by BCCI for a fee of P100.00. The Member agrees to immediately report the said incident in writing or by calling the BCCI Secretariat.
5. In case of changes in the Official Representative registered with BCCI, the card issued to the previous holder/ official representative will terminate automatically and all rights and privileges will be void. A new Card will be issued to the newly registered official representative. The newly issued Card will be valid for the unexpired duration only.

III. Changes to the BCCI Membership Privilege Card Program

1. The Terms, Conditions and Guidelines cannot be superseded or changed except by BCCI. BCCI shall use reasonable endeavours to provide Members with accurate and timely information regarding the BCCI Membership Privilege Card Program including any changes thereof; however, BCCI and its Partners shall not be liable in any way for failure to do so.
2. BCCI is not liable for any Award or Privileges not being available or being withdrawn for any reason whatsoever by any participating merchants.
3. BCCI reserves the right at all times, without notice and at its sole discretion:
 - a. To make any changes whatsoever to these Terms and Conditions;
 - b. To withdraw, cancel, withhold, substitute, deny access to or use of or in any way change any of the Privileges previously offered, to any Member, at any time, without prior notice, and BCCI will not be liable for any loss or damage suffered by the Member resulting from such withdrawal, cancellation, variation or change.
 - c. To terminate or materially alter BCCI Membership Privilege Card Program and/or revoke the membership of any Member to use the Card or to utilize any Privileges.
